Message from the President

The annual general meeting provides us with the opportunity to reflect back on the past year at the Gallery. Dealing with the day-to-day operational issues can keep the staff and board too busy to step back and take a good look at what has transpired this last year — to understand where we are today, and where we hope to be in the future.

With the departure of Gilles Hébert, 2010 started without a director. The Board faced the challenge by prudently adopting a new management model for the year under the leadership of then-president Veronika Mogyorody. While a search was conducted for a new director, the executive worked with senior Gallery management to oversee operations on an interim basis under a resource team model. Team members included Veronika Mogyorody, Sean White, Peter Wasyluk, Mary Weingarden and Brenda Francis-Pelkey, who worked closely with senior management staff members Patrick Brown, Mandy Salter, Linda Andrejicka and JoAnne Fletcher. I'd like to thank the entire Board for working through many long meetings involving detailed operational and financial discussions. They have been there through a tough year with support and words of encouragement, and I can't thank them enough for taking on this expanded role to keep the Gallery running efficiently.

The good news is that the AGW had a successful financial year that saw a modest surplus which will be allocated to reducing the Gallery's accumulated debt. This would not have been possible without the financial support of our core funding agencies, including the City of Windsor, the AGW Foundation, The Canada Council for the Arts, and the Ontario Arts Council, for both operational and special project grant funding through the Ontario Arts Council Arts Investment Fund.

I would like to thank the AGW Foundation Board for taking the necessary action required to keep the Gallery operating. There were many difficult issues and boardroom discussions this past year, and the Foundation simply did not give up on the institution. We appreciate both their financial and emotional support, and their important role as the lead donor in last year's successful President's Appeal campaign.

We also cannot forget our many wonderful volunteers who continue to do their work diligently and quietly, and always without enough recognition. They have been an important part of the Gallery's survival over the past 65 years, and their enthusiasm and commitment to all that they do behind the scenes is very much appreciated.

There have been many sponsors for the various programs and initiatives in 2010 that would simply be too numerous to mention here. We express our sincere gratitude to all of them and look forward to their ongoing support in the years ahead.

My first year as a President was interesting to say the least. The Gallery had a large deficit in 2009 due to the economic circumstances, and started the year without a director. We've come a long way, ending the year with a small surplus and the excitement of welcoming Catharine Mastin, our new director. The Board is pleased to have Catharine with us and we look forward to working with her in the future to make the AGW even better than it is today.

The AGW plays a vital role in Windsor's cultural landscape and must continue to do so during these trying fiscal times. We are more relevant in the community than ever before, as demonstrated by the City of Windsor's recent announcement to support cultural initiatives and institutions, including the potential development of the western super-anchor lands right behind the Gallery. We must play a key role in these discussions as the leading cultural institution in Windsor-Essex, and will partner with the City and all other stakeholders in realizing this endeavor.

With the start of a new term, the Board bids a fond farewell to two long-serving members, Brenda Francis-Pelkey and Barb Kuker. Their insight and input over the years has been extremely valuable. They have shown unwavering support of the Gallery, and have contributed their time, talents and resources without hesitation. They will be greatly missed in the boardroom for both their advice and wit. On behalf of the entire Board of Directors, I thank them for the many years of service. With their departure we also welcome two new members, Sigi Torinus and Michelle Tarailo, and look forward to working with each of them in the years to come.

In 2011 we will be presenting an updated strategic plan for the Gallery, and will be undertaking certain steps to strengthen current programs and improve operational efficiencies. Plans to return to fiscal stability and retire the accumulated deficit in the years to come are a priority. Although this will take time to implement and realize, we will begin this year with the first steps in this direction and will do all of this while continuing to provide our community with the first-class cultural institution that it deserves.

In conclusion, I would like to thank all of the dedicated individuals that form the critical support structure of the Art Gallery of Windsor — the staff, the Board of Directors, the AGW Foundation, the Volunteer Committee, the membership and our generous donors. Together, you are all instrumental to the survival and growth of the Gallery. Your commitment, dedication and generosity are greatly appreciated and critical for our continued success.

Message from the Director

It was only in the last month of 2010 that I joined the staff of this fine gallery and thus the achievements of this calendar year belong to the Board of Directors, staff and volunteers who ably guided the AGW during this time. At the core of the Gallery's mandate is the development of visual literacy through the collecting, showcasing and interpretation of the visual arts. Although a moratorium was placed on acquisitions given reduced curatorial staffing, the Gallery continued its commitment to annual exhibition and education programs for which it can be proud, and also its vital work in fundraising and event planning to build audiences and contribute to the Gallery's sustainability.

In the exhibitions area, highlights included three AGW-organized exhibitions which toured to several venues across Canada. These shows were the work of former curators Cassandra Getty and James Patten and were presented initially at the AGW in 2009. In 2010, the exhibitions *Kathleen Munn and Lowrie Warrener: The Logic of Nature, the Romance of Space*, and *It's Alive! Bertram Brooker and Vitalism!* toured to three more venues, and the Munn exhibition continues on to the Art Gallery of Ontario for a 2011 summer presentation in Toronto. Getty's exhibition *Yousuf Karsh: Industrial Images* also toured to the Art Gallery of Southwestern Manitoba and Patten's *Scott Conarroe: By Rail* was presented at Mount Saint Vincent Gallery in Halifax. The AGW is proud of the work of these two former curators and the publications accompanying these projects released in 2010, which offer important histories and contexts through which to gain insights into the artists' works. Scott Conarroe's forthcoming catalogue joins our 2011 publications program in partnership with Mount Saint Vincent Gallery and the McIntosh Gallery in London, Ontario.

Under the leadership of interim curator Mandy Salter, the AGW realized two important co-publications, *David Merritt: shim, sham, shimmy* with the Art Gallery of Hamilton and the McLaren Art Centre, and *The Films and Videos of Jamelie Hassan* co-published with Platform: Centre for Photographic and Digital Arts. Mandy's interim role also saw to some exhibitions from the Gallery's vault including that of The Morris and Beverly Baker Foundation collection, Group of Seven and Inuit art. The Gallery also loaned works from its collection by Jamelie Hassan, William Ronald, William Clapp and Joseph Dynes to other public art galleries in Canada. The important gesture of sharing collections with other galleries remains one more aspect of the AGW's contribution to Canadian culture.

In the education area, the Gallery offered more than 600 tours, studio classes and special events to more than 7,500 visitors in 2010. With the support of committed staff and volunteers, curriculum-based programs were presented to students in English and French from the public and separate school boards and private schools. The Gallery continued its ongoing commitments to *Art Discovery* programs, *Sundays in the Studio*, complementary public tours and drop-in events, including March Break drop-ins, *Fridays Live!* workshops, *Free Wednesdays* studios, the *Children's Festival of Art* and Chinese New Year. Artists including David Merritt, Denyse Thomasos, Jeet Aulakh and Shirley Williams joined the Gallery's programs with tours and talks. The AGW's Volunteer Committee continued to make important contributions for visitor programs with their ongoing art history film series shown on *Free Wednesdays*.

Special event highlights included the *Red Dress Event* in February, the *Red Bull Air Races* in June, and *Celebrating the Collection: The Group of Seven* in November. Sponsored programs included *Free Wednesdays*, thanks to the DWBIA, Caesars Windsor and AM800 CKLW, *Sundays in the Studio* thanks to a generous donation from the Graybiel family and the assistance of local artists, and the *Children's Festival of Art* was a huge success thanks to CAW Local 444. Venue rentals contributed crucial funds for ongoing operations and Taste Bud Bistro enjoyed a steady and growing clientele this past year. Another successful President's Appeal for 2010, led by the AGW Foundation, met fundraising targets and our name-space family continues to grow. 2010 also marked a good recovery for the AGW Foundation, enabling an increased allocation and stability for 2011. Behind the scenes, the recent retrofit of the mechanical system just keeps on giving since completion in 2008, with a total energy savings of \$355,000. Attendance also grew in 2010 by 20% over 2009, and the Uncommon Market Gift Shop, Art Rental & Sales and security continue their important work as the Gallery's front-and-centre ambassadors to visitors.

In all, 2010 demonstrated the AGW's continued capacity to maintain its course while operating as efficiently as possible in a challenging economic reality. Many thanks to all those AGW stakeholders who participated in the year's achievements. It will be a pleasure in the years ahead to continue to build on the work of so many fine and dedicated people who believe in the significance of this Gallery to the City of Windsor and beyond.

EDUCATION PROGRAMS

Tour Programs

Through more than 600 tours and studios, classes, special events and exhibition openings, over 7,500 people participated in AGW education programs in 2010. 2,561 children visited the Gallery, including over 1,700 students during the school year. With the help of staff and volunteers, curriculum-based programs consisting of tours and studios were presented to pre-school, elementary and secondary students in English and French from the public, separate and French boards, as well as from private schools. Many local groups participated including seniors, ESL groups, community living and special needs, Girl Guides and Brownies, birthday parties, etc.

Art Discovery Programs

With more than 40 programs offered, 146 children and adults took part in over 250 Art Discovery classes such as *Art Foundations for Youth*, *Thursday Tots*, *Adult Drawing*, *Teen Drawing Classes*, *March Break* and *Summer Camps* which featured painting, drawing, sculpture, collage, watercolour, design and more.

Sundays in the Studio

44 *Sundays in the Studio* workshops were presented by local artists in 2010, based on current exhibitions and seasonal holidays with more than 2,000 children and adults attending.

Independent Auditors' Report to the Members

We have audited the accompanying financial statements of the Art Gallery of Windsor which comprise the balance sheet as at December 31, 2010, the statements of revenue and expenses, changes in fund balances, and cash flows for the year then ended, and notes comprising a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian generally accepted accounting principles, and for such internal controls as management determines is necessary to enable the preparation of the financial statements that are free from material misstatement, whether due to fraud or error.

Auditors' Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform an audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures

selected depend on our judgment, including the assessment of the risks of material misstatement of the financial statements, whether due fraud or error. In making those risk assessments, we consider internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. 



Notes to Financial Statements

Year ended December 31, 2010

The Art Gallery of Windsor (the "Gallery") is incorporated without share capital under the laws of the Province of Ontario. The Gallery's principal activities are the operations of an art gallery and related services including the promotion and appreciation of the visual arts. The Gallery is a registered charity and as such is exempt from income taxes and able to issue donation receipts for income tax purposes.

1. Summary of significant accounting policies:

a) Basis of presentation:

In accordance with the practice common to similar organizations, the Gallery follows the fund basis of accounting to recognize in its accounts the responsibility to employ funds only for the purposes for which such funds were raised or contributed.

The Operating Fund reflects the day-to-day operations of the Gallery, including the activities of the Volunteer Committee.

The Capital Fund reports the assets, liabilities, revenues and expenses related to the Gallery's capital assets.

The Restricted Funds report funds designated for specific purposes, as follows:

The Arts Endowment Fund reports matching contributions from the Ontario Arts Council Foundation, and the net investment income earned thereon to be used by the Gallery for operating purposes.

The Building Fund reports revenue and expenses related to the maintenance of building and property.

The Equipment Replacement Fund reports revenue and expenses related to the purchase and maintenance of equipment.

The Permanent Collection Fund reports revenue and expenses related to the purchase of works of art.

The Director's Fund is for the purpose of making acquisitions for the permanent collection for which no single purchase may exceed \$1,000.

This fund is reimbursed by the Permanent Collection Fund for purchases made to a maximum of \$3,000 each year.

The Volunteer Committee Memorial Fund reports memorial donations. Expenses of the fund are at the discretion of the Board of Directors in consultation with the Volunteer Committee.

Funds may be expended out of the Building Fund, Equipment Fund and Permanent Collection Fund at the discretion of the Board of Directors. Funds may be expended out of the Director's Fund at the discretion of the Director of the Gallery. Only income distributed by the Ontario Arts Council Foundation to the Arts Endowment Fund is available for expenditure for operating purposes.

b) Revenue recognition:

The Gallery follows the deferral method of accounting for contributions, which consist of government grants and donations.

Restricted contributions are recognized as revenue of the appropriate fund in the year in which the related expenses are recognized. Contributions restricted for the purchase of capital assets are deferred and amortized into revenue on a straight-line basis, at a rate corresponding with the amortization rate for the related assets. Unrestricted contributions are recognized as revenue when received or receivable.

Pledges receivable are not recorded as an asset in these financial statements.

c) Investments:

Investments are designated as held for trading and are reflected at fair value based on quoted market prices.

d) Capital assets:

Capital assets are recorded at cost. Amortization is provided on a straight-line basis over the following periods:

(e) Inventories:

Inventories are stated at the lower of cost and net realizable value.

(f) Works of art:

Purchased works of art are reported as an expense in the fund making the acquisition in the year purchased. The value of donated works of art is not recorded, although donors receive a donation receipt for income tax purposes.

(g) Use of estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and reported amounts of revenue and expenses during the reporting periods. Significant items subject to such estimates and assumptions include the carrying amount of capital assets and valuation allowances for accounts receivable and inventories. Actual results could differ from those estimates.

7. Loan from Art Gallery of Windsor Foundation:

In June 2009, the Gallery negotiated a \$150,000 demand loan with the Art Gallery of Windsor Foundation. The demand loan is secured by a promissory note and bears interest at the rate of 4.0% per annum, with the interest payable upon demand of the principal portion.

At December 31, 2010, the balance outstanding on the demand loan is \$150,000.

8. Deferred revenue:

Deferred revenue represents revenues collected but not earned as of December 31. This is primarily composed of deposits on facility rentals, education programs, sponsorships and grant revenue related to future periods.

11. Ontario Arts Council Foundation:

Since 2001, the Gallery has contributed a total of \$104,981 to the endowment fund administered by the Ontario Arts Council Foundation (the "OAC Foundation"). The agreement with the OAC Foundation provides that for every \$1 of funds raised by the Gallery for endowment purposes, subject to an annual maximum amount and available funds, the OAC Foundation will contribute matching funds on a dollar-for-dollar basis, provided that the Gallery contributes a minimum of 34% of the endowment funds it has raised to the OAC Foundation. Phase III of the funding program ended on December 31, 2008 and no new funding has been announced to date. The combined funds are to be held in a trust fund to be administered by the OAC Foundation and be known as the Art Gallery of Windsor Arts Endowment Fund (the "Arts Endowment Fund").

The OAC Foundation, which holds the Arts Endowment Fund in perpetuity, is responsible for the investment of the funds held and the annual disbursement to the Gallery. In 2010 the Gallery received \$12,959 (2009 – \$3,759) from the OAC Foundation which has been recorded as interest income in the statement of revenue and expenses.

14. The Art Gallery of Windsor Foundation:

The Art Gallery of Windsor has a significant economic interest in the Art Gallery of Windsor Foundation which administers gifts and bequests received by it on behalf of the Art Gallery. The Foundation is incorporated under the Ontario Corporations Act and is a registered Charity under the Income Tax Act. According to the Foundation's bylaws, all resources of the Foundation must be provided to the Art Gallery or used for the Art Gallery's benefit.

The Foundation has not been consolidated in the Art Gallery's financial statements. Financial statements of the Foundation are available on request. Financial information of this unconsolidated entity as at December 31, 2010 and 2009 and for the years then ended are as follows:

15. Financial instruments:**Fair value**

The carrying value of the Gallery's cash, investments, accounts receivable, bank indebtedness, loan from the Art Gallery of Windsor Foundation, accounts payable and accrued liabilities approximate their fair value due to the relatively short periods to maturity of the instruments. The carrying value of the mortgage approximates its fair value as the terms and conditions of the borrowing arrangement are comparable to current market terms and conditions for similar items.

Interest rate risk

Interest rate risk is that risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Gallery is subject to interest rate cash flow risk with respect to its floating rate bank indebtedness.
